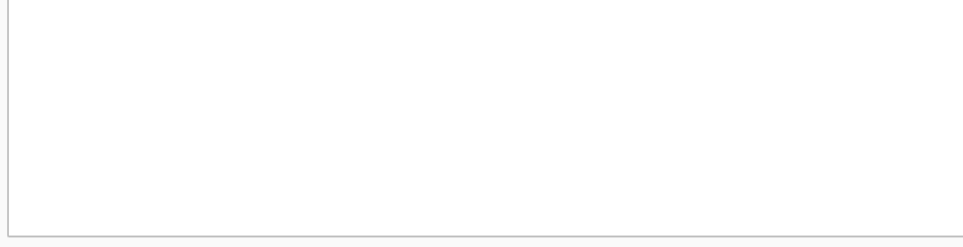

With reference to above, we are furnishing you the information received through Head/URDIP, Pune, as follows:

It is to inform you that Secretary, DIPP, GOI had requested the help of Secretary, DSIR, GOI to provide the services of prior art search to Indian Patent Office. As a follow-up of this request, an MoU was signed between Controller General of Patents, Designs and Trade Marks (CGPDTM) under the DIPP and CSIR-URDIP. CGPDTM/DIPP is our client in this case and we are providing services as per the scope and format discussed with them. The decision to outsource prior art searches was taken by the DIPP and they have to take into consideration the legality of this activity. The MoU and the related information are client's confidential documents and we do not know how much information the client wishes to put in public domain and how it would affect their working. Hence on CSIR part, we consider this information as exempt under Section 8(1)(d)&(e) being related to other Public Authority and is lying with CSIR in fiduciary relationship.
