ORDER

Heard the learned counsel for the petitioner. The learned counsel appearing for the respondent submitted that he has not obtained proper instructions from the respondent and he needs two weeks time for submitting vakalath as well as to file a written objection in this matter.



However, on a perusal of the affidavit filed along with the interlocutory application and the records produced in the Suit, it is obvious that the petitioner has a prima facie case. The records further reveal that balance of convenience is also in favour of the petitioner. Hence, it seems that unless an ad-interim direction in respect of the relief sought for by the petitioner is granted, it would cause irreparable loss to him.

In the result, the respondent is directed not to publish or exhibit any material which would infringe the copyright of the plaintiff over the copyright protected sound recording works of Vempati Ravi Shankar, for a period of three weeks from today.
